Your Application for Reinstatement of Registration (P.Ag., Tech.Ag. or Agrologist-in-Training (AIT) is subject for review by the Registrar and/or the Admission and Registration Committee (ARC) of the Provincial Council.

The reinstatement policy and procedure guidelines apply to individuals who were previously registered in Manitoba, or who were previously registered in another province and who wish to resume registered practice of Agrology and be listed on the Register of those entitled to practice agrology in Manitoba.

The purpose of the policy and guidelines is to protect the public. The decision process includes an evaluation of information relevant to re-engaging in registered practice after an extended absence.

The policy and procedure guidelines do not limit the right of “The Manitoba Institute of Agrologists” to request and evaluate any information it deems necessary and to make a fair and objective decision in the public interest.
